Thank you for your interest in the *Smart Buildings Alliance for Smart Cities* and welcome to this SBA Membership Explanatory Note.

The SBA offers 3 membership statuses and 2 types of membership. Each application for membership is reviewed collegially by the SBA Board or by the Board of Directors for Associate Membership. Payment of membership fees is made by bank transfer upon receipt of the invoice.

# The different statuses of membership

- 1. **Honorary member:** member wishing to participate actively in the life of the association by increasing its visibility in all the actions undertaken by the SBA.
- 2. **Associate member:** member who brings added value to the association by supporting it, presenting it at joint events (NB: membership by decision of the Board of Directors)
- 3. **Member:** companies of all sizes, public institutions and local authorities, professional unions in the sector, associations under the 1901 law, competitiveness clusters, IDEEs, consortia that wish to contribute to the work and life of the SBA to make Smart Home and Smart Building in the Smart City finally become a reality.

# The different types of membership

- 1. **Membership at national level**: open to all membership statuses
- 2. **Membership at regional level:** open only to companies with < 250 employees and local authorities.
